Representative Matters

- Successfully developed coverage defenses for a cyber insurer following a cyberattack on its insured, whose business focused on ecards. Worked closely with the primary insurer's counsel to develop a strategy to obtain materials necessary to the evaluation of the claim, including coverage. Engaged an outside consultant to assist with document requests, given the insured's repeated delay and refusal to provide necessary materials. We successfully identified differences among the insured's "customers," which made clear that one of the entities allegedly harmed by the hack was not a customer but instead was a supplier. Analysis of the facts detailing exactly how the supplier's operations were impacted by the hack and what led to its alleged loss demonstrated that while coverage was available for the customers, coverage was not available for the claim by the supplier.
- Disposed of a case in which we were retained pursuant to a private D&O policy to defend and protect the interests of a technology company following receipt of a cease and desist letter and a demand for damages from a private equity company for alleged breach of an investment agreement. Reviewed extensive investment contracts, interviewed clients, and obtained all purported disclosure documents, including screenshots on various web pages, in order to evaluate demands and develop the framework of a response and a strategy to defeat the claim. Prepared an extensive response letter, including challenging the private equity company's

interpretation of contract provisions and rights, which resulted in the withdrawal of all demands and the cessation of the dispute.

- Favorably resolved for a fiduciary insurer an ERISA and breach of fiduciary duty suit against the trustees of a pension plan of a public corporation following the acquisition of the insured by a competitor. Worked closely with defense counsel on the strategy for defense and development of the history concerning actions by the trustees to the plan, both prior to and following acquisition. The development of factual history ultimately led the fiduciary insurer for the acquiring corporation to reverse a denial of coverage and agree to allocation between towers. Collaborative effort with defense counsel resulted in a favorable resolution well below the settlement value pursued by the plaintiffs and recommended by the mediator at the first mediation. The resolution was well within the client's layer of coverage, given the significant contribution by the acquiring corporation's insurer to settlement and defense fees and costs.
- Achieved an early and favorable resolution for a fiduciary insurer in an ERISA and breach of fiduciary duty suit against the trustees of a pension plan of a mutual fund company, which contained a concentration of proprietary funds whose inclusion and performance were being challenged by the plaintiffs. Partnered early on with defense counsel on the strategy for a motion to dismiss and potential early resolution. Despite demands and valuations by the plaintiffs' experts, which suggested a settlement value in the excess layers of coverage, by pursuing an early resolution and working closely with defense counsel at mediation, a settlement within the insurer's primary layer of coverage was achieved. The early and successful resolution and support provided by the insurer to the insured led them to seek an expansion of the business relationship with the insurer, while simultaneously allowing the insurer to save part of its limits that early facts suggested would be completely lost.
- Successfully resolved a coverage dispute on behalf of a private equity insurer arising out of multiple suits filed against a private equity insured arising out of the insured's investment in an insurer providing automobile coverage in the Midwest. Through an extensive review of underlying documents, we were able to develop a series of coverage defenses that called into question the scope of coverage available for a suit brought by the liquidation trustee of the now-defunct insurer. Despite threats by the insured's coverage counsel of its intention to pursue a declaratory judgment action against the insurer, an agreement was reached whereby the insured and insurer partnered to work together and each contribute to a successful resolution of the trustee's claims.
